Processing of information as part of the investigation of impediments to marriage

Name of register: Documents related to the investigation of impediments to marriage

Controller and related contact information and Data Protection Officer: The parish or central registry investigating the impediments to marriage. The contact information is available at <https://evl.fi/contact-us/parish-offices>

Intended use of personal data and legal justification: The investigation of impediments to marriage is a prerequisite for marriage as prescribed by the Marriage Act (Avioliittolaki 234/1929) and Marriage Decree (Avioliittoasetus 820/1987). A member of the Church can request that an investigation of impediments to marriage be carried out by the parish in which the individual is a member. A member of the Evangelical Lutheran Church of Finland can initiate the investigation of impediments to marriage through the Church's online service (<https://esteidentutkinta.fi/?locale=en-US>) or by submitting a completed request for investigation form to the member's own parish.

The personal data requested on the form is necessary for the investigation of the impediments to marriage. Once the impediments to marriage have been investigated, the applicants are issued a certificate of no impediment, which is valid for four months from the date of issuance.

For the purposes of processing personal data in the investigation of the impediments to marriage, the register Controller's statutory duty pursuant to Chapter 3 of the Marriage Act serves as the legal justification in compliance with EU General Data Protection Regulation, Article 6.1.c.

Sources of information: The applicants have voluntarily provided the information requested on the form for the purpose of investigating the impediments to marriage. As part of the investigation process, the investigating parish or central registry also uses the information about the member(s) in question as found in the Church's shared membership database Kirjuri. If one of the applicants is not a member of the Church, personal data concerning this applicant is retrieved from the Population Information System. If one of the applicants is a foreign national or living abroad, the applicant may need to provide certificates issued by a foreign authority for the needs of the investigation.

Disclosure of information: Documents related to the investigation of impediments to marriage and the certificate of no impediment are not disclosed to any party other than to the marriage applicants in question.

Personal data retention period: The retention period for the documents is set out in the document filing plan. Documents related to the investigation of impediments to marriage are retained for 10 years. The certificate stating that the investigation has been completed is retained permanently.

Access to data: You have the right to know what information about you is stored in the documents related to the investigation of impediments to marriage. You can review your information by personally visiting the parish/central registry that investigated the impediments or by submitting a written request to review the information with your parish/central registry.

Rectification of data and restriction of use: You have the right to demand the rectification of any inaccurate information within the documents related to the investigation of impediments to marriage. You cannot demand any restriction of use concerning the processing of personal data while your rectification request is being handled.

Right to object: You do not have the right to object the processing of personal data concerning you as part of the investigation of impediments to marriage, because your information is being processed by virtue of the law.

Right to transfer data from one system to another: Since the processing of information as part of the investigation of impediments to marriage is carried out by virtue of the law and not your consent, you do not have the right to have the relevant personal data concerning you transferred in electronic format to another system.

Right to file a complaint with the supervisory authority: You have the right to file a complaint with the supervisory authority regarding the processing of personal data.
